Project Description:

The Allied Health Building will complete the planning Health Care Academic Quad on the east end of Chancellor's walk. In keeping with the campus standards and specifically the University Intentions that the Quad be composed of identical buildings, this project will maintain the massing, materiality, and detail exhibited on McNeil Hall and the Teaching Lab.

The new Allied Health building will be approximately 145,000 S.F. slab on grade first floor with three supported levels and roof structure. The super structure will be designed as a steel frames structure. The second, third, and fourth (mechanical mezzanine) structure will be steel beam and girders supported by steel columns. The Roof will be steel bar joist supported on steel beams and girders spanning between steel columns.

The exterior of the building will be constructed of structural gauge studs, sheathing, insulation and aluminum fixed windows, brick façade, GFRC columns and cornice. The roofing finish material shall be asphalt shingles.

The buildings heating and cooling system will tie into the campuses existing chilled /heated four piping service from remote chillers and boiler plants. The buildings internal primary HVAC system will be comprised of Variable Air Valves, fan coil units, cabinet unit heaters, air handling units, hot and cold water distribution pumps, and a possible heat recovery system.

The site will require demolition of existing parking lot and concrete curb and gutter, minimal clearing of existing tree, as well as removal and rerouting of existing storm water piping with new catch basin. The site is flat but may require minimal importation of material for green areas due to the demolition of the parking lot. The building foundation system will be poured in place over ground improving, stone piers to mitigate possible settlement caused by seismic activity.

Included in this scope /estimate is the cost to replace the existing McQuay Chiller with a SMARDT Chiller at the central chiller plant. This project would be done in conjunction with the Allied Health Building.

Submittal of Bidder Qualification:

W.M. Jordan Company, acting as the Construction Manager for University of North Carolina at Wilmington, will evaluate and pre-approve subcontractors based upon response to the North Carolina State Construction Offices, Prequalification Form for First –Tier Subcontractors under CM at Risk. Appeals:

A firm may appeal the denial of prequalification based on **G.S. 143-135.8(b)(2)** after written appeal is received, the Prequalification Committee will rule on the appeal and notify the company of their ruling within <u>Five</u> business days.

Prequalification for Re-bids:

For any bid package not opened on bid day, a re-bid date will be established and re-advertised. Bids will be accepted from companies who have previously been prequalified for re-advertised bid package(s) whether they actually submitted a bid on the original bid date or not. However, the prequalification submittal period will be re-opened for re-advertised bid package(s) to allow additional companies to participate in the re-bid under the following process:

- Within five calendar days of re-advertisement, company shall notify Prequalification Committee
 in writing of their intent to submit a prequalification and bid. Bid documents will then be made
 available for download or view on our FTP site while company is preparing prequalification form
 and shall submit prequalification form to the Prequalification Committee. Otherwise,
 company's bid will not be accepted.
- The appeal process for the re-bids will follow the same process as indicated in G.S. 143-128.1 (c)

- In the event the company has not received notification of prequalification by the re-bid date, the company will be allowed to submit a bid on the re-advertised bid package(s) subject to prequalification.
- In the event the company is appealing a denial of re-bid prequalification by submitting a written appeal within three days of receipt of denial notification, the company will be allowed to submit a bid on the re-advertised bid package(s) subject to the final decision of the appeal. If the company's bid is opened prior to a final decision on the appeal and the bid is not the lowest responsive monetary bid for the re-advertised bid package(s), the appeal shall be terminated and rendered not necessary.
