## ABUSER TREATMENT PROGRAMS

The Council certifies abuser treatment programs utilized by the North Carolina court system to assist batterers. From April 2010 - March, 2011, the Council certified ninety-nine programs statewide.

- 73% of the total referrals were accepted into an abuser treatment program.
- The criminal court system provided 71% of the total number of program referrals.
- The criminal court system provided 71% of the total number of accepted referrals.
- The Division of Social Services provided 11% of the total number of referrals.
- The Division of Social Services provided 10% of the total number of accepted referrals.
- There were 463 more participants who completed the abuser treatment curriculum than those who were terminated from the program.

### DISPLACED HOMEMAKER PROGRAMS

The North Carolina Council for Women distributes state funding to local county programs to be used for providing services to displaced homemakers. The local programs provide job counseling, job training, job placement services, health education, counseling services, and financial management services to displaced homemakers.

- The displaced homemaker programs served clients 5,510 in 2009-2010. The 2010-2011 total represents a 3% increase in the number of clients served.
- The Mecklenburg county program served the highest number of clients (700) followed by Rockingham (311) and Alamance (279) counties.
- In 2007-2008, 49% of the clients served were white. Blacks and Hispanics comprised 41% and 5% of the total number of clients served.
- The 25-34 age category comprises the largest group served.
- Women comprised 94% of the clients served.
- Of the total number of clients served, 14% obtained full time employment while 14% obtained part time employment.
- Of the total number of clients served, 28% were placed in a four year college, community college or trade course.
- Of the total number of clients that received an education placement, 57% were placed in a community college.

#### DOMESTIC VIOLENCE PROGRAMS

The North Carolina Council for Women distributes state funding to local county programs for victims of domestic violence and to the North Carolina Coalition Against Domestic Violence which provides technical assistance to the programs. Funding is provided to domestic violence programs in all counties. Each local county program provides a 24-hour confidential crisis hotline, crisis intervention services, referrals to other community resources as needed, emergency shelter or shelter referral, advocacy, counseling, and community education.

- The domestic violence programs served 66,320 clients in 2009-2010. The 2010-2011 total represents an 8% decrease in the number of clients served.
- The Wake county program served the highest number of clients at the local level (3,720) followed by Randolph (3,192) and New Hanover (2,206) counties.
- Whites comprised 56% of the total number of clients served by the local county programs.
   Blacks comprised 26% of the total number of clients served, while Hispanics accounted for 10%.
- In 2010-2011, 33% of the clients served were in the 45-54 age groups. The 55-64 age group comprised 19% of the total number of clients served.
- Women comprised 84% of the total number of clients served while men comprised 16%.
- A majority of services provided by the programs included distributing information to clients followed by advocacy.
- In 2009-2010, the local programs received 120,666 calls on the 24-hour crisis lines. In 2010-2011, 95,877 calls were received, representing a 21% decrease in volume.
- In 2009-2010, 1,721 clients were referred to other shelters due to a lack of space. Referrals increased in 2010-2011 by 47%.

### SEXUAL ASSAULT PROGRAMS

The North Carolina Council for Women funded seventy-five local county programs for victims of sexual assault and to the North Carolina Coalition Against Sexual Assault which provides technical assistance to the local county programs. Each county program provides a 24-hour confidential crisis hotline, crisis intervention services, referrals to other community resources as needed, emergency shelter or shelter referral, advocacy, counseling and community education.

- In 2009-2011, the local county programs served 13,392 clients. The 2010-2011 total number of clients served represents a 4% increase in the total number clients served.
- The Mecklenburg county program served the highest number of clients at the local level (740) followed by Chatham (694) and Craven (650) counties.
- Whites comprised 59% of the clients served while 20% were black. Hispanics comprised 12% of the total clients served.
- In 2010-2011, 26% of the clients served were in the 26-40 age groups.
- Women comprised 89% of the total number of clients served while men accounted for 11%.
- Adult rape comprised 24% of the total number of assaults. This is a 6% increase compared to the 2009-2010 data (3,103) reported.
- In 2010-2011, 37% of the offenders were a relative of the victim while 33% were an acquaintance.
