EXECUTIVE SUMMARY

The Office for Historically Underutilized Businesses (HUB Office) serves as an advocate for HUB vendors, which includes minority and women-owned business enterprises, disabled-owned businesses, disabled business enterprises (organizations that employ disabled individuals), and non-profit work centers for the blind and severely disabled. The HUB Office promotes the State's on-line vendor registration and HUB certification/verification process, provides technical assistance, and conducts training on how to conduct business with state government. The HUB Office captures data reflecting the State's HUB utilization and expenditures with state agencies, community colleges, public schools and universities, while also serving as a resource to these agencies.

Executive Order 150 states that North Carolina's Historically Underutilized Business participation goal is <u>at least</u> ten percent (10%), by dollar amount, of the State's purchases of goods and services, will be derived from HUB vendors. Executive Order 150 further requires the submission of quarterly HUB purchasing reports to the HUB Office. The goal for fiscal year 2001-2002 (July 1, 2001 through June 30, 2002) currently remains at 10%.

The following legislation also addresses the State's minority business goals and reporting requirements:

- **G.S. 143-48 (b)** states "in part".... " That every governmental entity required by statute to use the services of the Department of Administration in the purchase of goods and services and every private, non-profit corporation other than an institution of higher education or a hospital that receives an appropriation of five hundred thousand dollars (\$500,000) or more during a fiscal year from the General Assembly shall report".
- **G.S. 143-128 (f)** states "in part".... " The State shall have a verifiable **ten percent (10%)** goal for participation by minority businesses in the total value of work for each building project ".

During the <u>4th Quarter</u> of fiscal year 2000-01 (April 1, 2001 – June 30, 2001), HUB participation for the State of North Carolina, as reported by the State Reporting Entities, is <u>8.67%</u>. Purchases reported totaled, **\$1,180,464,966** with **\$102,355,015** reported HUB participation.

At Fiscal Year-End 2000-01 (July 1, 2000 - June 30, 2001), HUB participation for the State of North Carolina, as reported by the State Reporting Entities, is <u>8.86%</u>. Purchases reported total **\$5,195,006,350** with **\$460,315,864** reported HUB participation. Compared to the previous fiscal year's (July 1, 1999-June 30, 2000) reported HUB participation of **\$384,307,890**, there is a percentage increase of 19.8% or \$76,007,974 in reported HUB participation.

State Reporting Entities responsible for reporting HUB participation are as follows:

The State Reporting Entities submit a <u>Quarterly HUB Purchasing Report</u> to the Office for Historically Underutilized Businesses. The reports are due no later than thirty (30) days after the end of each quarter and reflect each entity's HUB purchases within the following categories:

- Term Contracts
- Commodities
- Service Contracts
- Construction Expenditures (that which is under the entities' delegation; but not captured by the State Construction Office.)

At **year-end**, the Council of State Agencies reported **4.54%** HUB participation. The Agencies reported a total of \$197,394,575 in purchases with \$8,955,967 reported HUB participation.

100% Reporting Conclusively for 4th Quarter

4th Quarter

For **4**th **Quarter**, the Supporting Agencies reported **8.74%** HUB participation. The Agencies reported a total of \$36,980,435 in purchases with \$3,232,582 reported HUB participation.

Year-End

At **year-end**, the Supporting Agencies reported **6.58%** HUB participation. The agencies reported a total of **\$201,760,043** in purchases with **\$13,270,995** reported HUB participation.

Community Colleges 4th Quarter and Year-End (FY 00-01)

100% Reporting Conclusively for 4th Quarter

4th Quarter

For 4th Quarter, the Community Colleges reported 6.88% HUB participation. The Colleges reported a total of \$44,483,813 in purchases with \$3,062,647 reported HUB participation. In the prior year (FY 99-00), a total of 38 out of 59, or 64%, of the Community Colleges submitted conclusive quarterly reports. Currently 59 out of 59, or 100%, of the Colleges have submitted conclusive reports.

Year-End

At **year-end**, the Community Colleges reported **5.88%** HUB participation. The Colleges reported a total of **\$199,106,087** in purchases with **\$11,715,471** reported HUB participation. In the prior year (FY 99-00), a total of 38 out of 59, or 64%, of the Community Colleges submitted conclusive quarterly reports all four (4) quarters. Current fiscal year (FY 00-01) records 44 of the 59, or 75% of the Community Colleges reporting conclusive report all four (4) quarters.

It should be noted that for the past three (3) consecutive quarters, 93% reported conclusively and for the past two (2) consecutive quarters, 100% reported conclusively. We attribute this significant turnaround to concerted outreach efforts and training provided by the HUB Office. The HUB Office commends the Community Colleges for this effort.

Public School Districts 4th Quarter and Year-End (FY 00-01)

74% Reporting Conclusively for 4th Quarter

4th Quarter

For **4**th **Quarter**, the Public School Districts reported **6.18%** HUB participation. The School Districts reported a total of \$370,819,299 in purchases with \$22,916,316 reported HUB participation. In the prior fiscal year (FY 99-00), a total of 29 out of 116, or 25%, of the Public School Districts submitted conclusive quarterly reports. Currently 86 out of 117*, or 74%, of the Districts have submitted conclusive reports.

Year- End

At **year- end**, the Public School Districts reported **5.83%** HUB participation. The School Districts reported a total of \$1,412,808,061 in purchases with \$82,361,206 reported HUB participation. In the prior fiscal year (FY 99-00), a total of 29 out of 116, or 25%, of the Public School Districts submitted conclusive quarterly reports all four (4) quarters. Current fiscal year (FY 00-01) records a total of 52 out of 117*, or 44%, of the Public School Districts submitted conclusive quarterly reports all four (4) quarters. It should be noted that for the past three (3) consecutive quarters, 58% reported conclusively and for the past two (2) consecutive quarters, 71% reported conclusively. We attribute this significant increase to concerted outreach efforts and training provided by the HUB Office.

State Universities 4th Quarter and Year-End (FY00-01)

95% Reporting Conclusively for 4th Quarter

4th Quarter

For 4th Quarter, the State Universities reported **6.02%** HUB participation. The Universities reported a total of \$206,601,735 in purchases with \$12,444,887 reported HUB participation. In the prior year (FY 99-00), a total of 10 out of 19, or 53%, of the State Universities submitted conclusive quarterly reports. Currently 18 out of 19, or 95% of the Universities, have submitted conclusive reports.

Year- End

At **year-end**, the State Universities reported **6.34%** HUB participation. The Universities reported a total of **\$539,839,868** in purchases with **\$34,239,637** reported HUB participation. In the prior year (FY 99-00), a total of 10 out of 19, or 53%, of the State Universities submitted conclusive quarterly reports all four (4) quarters. Current fiscal year (FY 00-01) records a total of 14 out of 19, or 74% of the Universities, submitted conclusive quarterly reports all four (4) quarters. It should be noted that for the past three (3) consecutive quarters, 79% reported conclusively and for the past two (2) consecutive quarters, 89% reported conclusively. We attribute this significant increase to concerted outreach efforts and training provided by the HUB Office.

State Construction Office 4th Quarter and Year-End (FY00-01)

4th Quarter

The State Construction Office (SCO) reported **17.40%** HUB participation. SCO reported a total of \$119,416,982 in purchases with \$20,780,236 reported HUB participation.

Year-End

At **year-end**, SCO reported **12.47%** HUB participation. SCO reported a total of \$459,254,998 in purchases with \$57,267,894 reported HUB participation.

SUMMARY OF REPORTING ENTITITES

The following illustrates the State Reporting Entities that met or exceeded the State's 10% goal at fiscal year end 2000-2001.

Cabinet Agencies:

Seven (7) of the ten (10), or **70%** of the Cabinet Agencies, met or exceeded the State's goal, with the Departments of Administration, Correction and Cultural Resources reporting 24.81%, 20.03% and 15.88%, respectively. Two (2) additional Cabinet Agencies were in striking range of meeting the goal with 9.36% and 9.87% reported participation.

Council of State Agencies:

Three (3) of the nine (9), or **33%** of the Council of State Agencies, met or exceeded the State's goal, with the Office of the State Auditor, Department of Insurance and Department of Justice reporting 14.21%, 14.58%, and 10.64%, respectively.

Supporting Agencies:

Five (5) of the twelve (12), or **42**% of the Supporting Agencies, met or exceeded the State's goal.

Community Colleges:

Nine (9) of the fifty-nine (59), or **15%** of the Community Colleges, met or exceeded the State's goal.

Public School Districts:

Eight (8) of the one hundred seventeen (117), or **7%** of the Public School Districts, met or exceeded the State's goal.

State Universities:

Six (6) of the nineteen (19), or **32%** Universities, met or exceeded the State's goal.

State Construction Office:

Exceeded the State's goal, reporting 12.47%

The State's **Year-To-Date** (July 1, 2000 - June 30, 2001) HUB participation rate is at **8.86%.** The Office for Historically Underutilized Businesses wishes to impress upon all reporting entities the need to continue to make concerted efforts to increase the total amount of goods and services acquired from HUB vendors. Under Executive Order 150, the HUB participation goal for the current fiscal year is that <u>at least ten percent (10%)</u> of the State's purchases of goods and services be derived from HUB vendors.

OUTREACH

During the year, the HUB Office continued to embark on aggressive outreach efforts to inform HUB vendors and purchasing officials of the HUB Program, Vendor Link, State's New E-Procurement Initiative, \$3.1 Billion Higher Education Bond and Executive Order 150. The HUB Office conducted twenty-eight (28) onsite training sessions for purchasers and vendors. Two (2) HUB Vendor Orientation Sessions were held in which 180 HUB vendors, local purchasing agents and officials, and other resource agencies, attended. In addition to the aforementioned HUB outreach efforts, the Office participated in fifty (50) workshops, presentations, seminars and/or conferences throughout the year. The HUB Office was also featured on "Inside N.C.", a cable public television show, which highlighted the HUB Office and opportunities for Historically Underutilized Businesses with the State of North Carolina.

ACCOMPLISHMENTS

A review of highlights and significant accomplishments of the Office for Historically Underutilized Businesses include:

- Cabinet Agencies, collectively, exceeded the 10% goal with reported year-end participation of 11.56%.
- 17% increase from the previous fiscal year of HUB reporting entities reporting conclusively for all four quarters.
- Handled over 2000 inquiries from HUB vendors by providing assistance and/or information on the State's HUB Program, HUB Certification, E-Procurement, Purchasing and Construction Opportunities.
- Certified 572 vendors as HUB vendors during the year through Vendor Link, with a total of 1629 certified HUB Vendors in the Vendor Link database.
- HUB Office moved into newly renovated and expanded office space.
- Assured that HUB issues, matters and concerns were in the forefront of the State's new E-Procurement Initiative.
- Assured that HUB issues, matters and concerns were in the forefront of the State's \$3.1 Billion Higher Education Bond Referendum.
- Assisted State Treasurer's Office with planning and coordinating Financial Business Opportunities Information Session for HUB firms interested in bidding on the financing of State's \$3.1 Billion Higher Education Bonds.
- Held two HUB Advisory Council Meetings as outlined per Executive Order 150.
- Hosted two HUB Vendor Orientation Training Sessions with over 180 participants.
- Conducted, facilitated and/or participated in twenty-eight (28) training sessions for purchaser and vendors.
- Participated in more than 50 conferences, workshops, seminars, and/or presentations promoting the HUB Office, Vendor Link, E-Procurement, \$3.1 Billion Higher Education Bond Program and Executive Order 150.
- Featured on "Inside N.C." Public Television Show.
- Hosted Russian Business Delegation who were interested in learning about small business programs in the State of North Carolina.

April 4, 2001

Participated in Highway Patrol Quarterly HUB meeting held in the Department of Crime Control & Public Safety. All attendees were encouraged to improve the HUB participation within each section.
