The Design-Build Approval LOG (Updated 5/25/2023): Eight approved, One approved for Design Build Bridging, and One Request Withdrawn.

Design Review Section- 731 plans received Year-To-Date (YTD); 643 responses provided YTD; Exemption Projects- 135 YTD; and Tent Permits- 22 YTD.

Mr. William Johnson, RA provides an update on OC-25 Form (Cost Estimate):

The sub-committee of the Innovations Committee is considering the update of the OC-25 Form has been sent both a draft revised OC-25 Form as well as the Tab Requirements for Development that frames the process of modifying the OC-25 for review and comment.

A new OC-25 Worksheet is scheduled to be completed by the end of this summer for use by state agencies in preparation of their capital priority projects they will request funding from the 2024 short session of the General Assembly.

SCO has utilized an existing NCDIT contract to hire a new programmer (May 2023 to May 2024) to work on needed changes to Interscope to facilitate the OC-25 Form revisions. Said programmer has previously worked for the NCDOA Non-Public Education Division on their software platform, which is the same platform as Interscope.

Mr. Ali, PE provides an update on Executive Order 266:

The ad-hoc groups continue to work. The ad-hoc effort concludes in early July 2023, at which point all research and recommendations must be presented to the EO266 Primary Committee. The primary committee will use the ad-hoc's data to craft a working policy document. In other news, SCO, NC Office of Recovery and Resiliency (NCORR) and Bailey Recktenwald (Governor's Office, Climate Change Policy Advisor) participated in a roundtable discussion at day 2 of the NC Oyster Summit on May 11 (organized by the North Carolina Coastal Federation). The roundtable topic was nature-based solutions for stormwater management as it relates to flooding outside of the defined floodplain (i.e., urban pluvial flooding). Approximately 100 people participated, with discussion of many good ideas.
