- State Construction Conference The 42nd Annual State Construction Conference was held on March 2, 2023, at NC State University's McKimmon Conference and Training Center.
- Consulting Services Section
  - Advertised, interviewed, and awarded a contract to a Designer and a Construction Manager at Risk (CMR) for the NCDOA Consolidation effort that will relocate all staff currently working in the Administration Building. Design drawings were approved for the renovation of the Albemarle Building 3rd floor to support the relocation effort and construction is expected to be underway by July 1st.
  - Identified and obtained the services of a retired Level III State Electrical Inspector to support a workload shift to address another staff inspector being out on medical leave.
  - Reclassification of SCO Electrical Inspector positions from Engineering Technician III to Engineer II. The reclassification resulted in a higher salary range, a pay increase for the existing inspectors, and recognition of the job duties and responsibilities of the work said inspectors are required to perform by NC General Statute. This reclassification will assist with the retention and recruitment of electrical inspectors.
- Capital Project Management Section

STAFFING: Permanent Hire -State Electrical Inspector (Engineer II), (05/09/2023). Interview for Permanent Hire - Program Manager II (06/20/2023). DHHS CAMPUS PHASE I: Total Project Cost - \$277,700,000 Construction is approximately 24% complete. DEQ REEDY CREEK CAMPUS EXPANSION AND RENOVATION: Total Project Cost - \$68,390,000 Schematic Design submitted 05/23/2023. Construction Manager at Risk agreement finalized with SKANSKA and DEQ. BATH BUILDING DEMOLITION: Total Project Cost - \$7,000,000 Project on schedule to bid November 2023 with construction start February 2024.

 Facilities Condition Assessment Program (FCAP)/Construction Management FCAP has completed its current State asset inspection cycle. This effort began in 2018 and involved visiting every State asset greater than 3,000 gross-square-feet. This equates to over 111,000,000 gross-square-feet, distributed between 4,700 buildings, spread across 98 of North Carolina's 100 counties. The group finished on schedule with zero safety incidents.

The Construction Management group has processed 92 construction projects worth over \$185 Million Year-To-Date.

Design Review

886 submittals were logged in Interscope, 832 responses sent out and 158 exempt projects processed in addition to issuing 23 tent permits. Compared with data from the past 10 years for the first two quarters, said volumes have surpassed the previous year's numbers.
