### **13. INNOVATIONS SUBCOMMITTEE UPDATE**

Mr. Ali, provided updates:

The State Construction Office (SCO) acts as the floodplain manager for projects located on state land. SCO currently enforces Executive Order (EO) 123 which is meant to minimize flood damage to state owned assets. Governor Cooper issued EO 226 in July 2022, instructing NCDOA through SCO, in consultation with NCDOT, NCDEQ, NCEM, and NCORR, to update the North Carolina Uniform Floodplain Management Policy. This effort must be completed by January 2024. SCO has completed preliminary research, reviewing the policies and similar efforts undertaken by neighboring States. In November 2022, the EO 226 Primary Committee, which is comprised of representatives from the above mentioned agencies, met and discussed efforts moving forward. Ad-hoc groups are being organized. These groups will research the topics, and propose policy change, indicated by EO 226. These efforts include, in part, revising the existing policy, considering/implementing sea level rise and climate change, and extending the policy to include all state funded projects.

# **16. STATE CONSTRUCTION OFFICE REPORT**

Mr. Shumsky, provided the following updates:

- Plans received as of (11/29/2022) were 1,149, responses as of (11/28/2022) were 1,069, Exemption Request projects were 186, and Tent Permits were 31.
- July 25, 2022; Executive Order No 266 Updating the North Carolina Uniform Floodplain Management Policy for State Construction.
- ▶ 93 days until the 42<sup>nd</sup> Annual State Construction Conference (March 2, 2023)
- The Frank B. Turner Award is presented by AIA North Carolina, the North Carolina Chapter of the American Society of Landscape Architects, the Consulting Engineers Council of North Carolina, and the Professional Engineers Council of North Carolina at the Annual State Construction Conference. The award purpose is to recognize a state employee who has made an outstanding professional contribution to the built environment, as exemplified by the professional life of Frank B. Turner. The Award Selection Committee is comprised of representatives from the North Carolina Design Professional Associations', as well as past award recipients. Frank B. Turner earned his BS and MS in Mechanical Engineering from NCSU. He also worked at the Newport News Shipyard, taught engineering at NC State College, was superintendent of the UNC Power Plant, assistant superintendent for the Moncure Power Plant, combustion engineer for CP&L's operations, and contributed to the WWI effort by teaching Aeronautical Engineering to Navy pilot trainees at NC State College. In North Carolina State Government Mr. Turner held a position at the NC Budget Bureau before retiring as director of the Property Control and Construction Division of the Department of Administration.
